<u>ORDER</u>

Provisional Affiliation was granted for starting MBA programme with an intake of 60 students at Holy Grace Academy of Management Studies, Kuruvilassery, Mala, Thrissur during the academic year 2005-06 vide U.O. read as 1st above.

2. The intake has been increased from 60 to 120, with effect from the academic year 2011-12 with permission to admit students during the academic year 2012-13 vide U.O. read as 2nd above.

3. The Principal has not submitted the renewal NOC from Government for the academic year 2022-

23 as insisted vide U.O read as 3rd above, which is mandatory for granting Continuation of Provisional Affiliation.

4. Continuation of Provisional Affiliation for MBA programme with 120 seats (2 batch with 60 seat each) was granted for the academic year 2021-22, vide U.O read as 6th above.

5. The Principal, Holy Grace Academy of Management Studies, Kuruvilassery, Mala, Thrissur has applied for Continuation of Provisional Affiliation to MBA programme for the academic year 2022-23 vide paper read as 4th above. An amount of ₹1,55,455/- (Rupees One Lakh Fifty Five Thousand Four Hundred and Fifty Five only) has been remitted by the Principal towards administration fee, affiliation fee and fine of ₹1105/-(Rupees One thousand one hundred and five only) for late submission of application vide chalan No.221022939 dated 13.01.2022

6. The AICTE has extended its approval to the MBA programme in the college for the academic year 2022-23, vide paper read as 5th above.

7. Considering the above, sanction has been accorded by the Vice Chancellor on 10.11.2022, for granting Continuation of Provisional Affiliation to MBA programme with an intake of 120 students (2

batches of 60 students each) in Holy Grace Academy of Management Studies, Kuruvilassery, Mala, Thrissur for the academic year 2022-23 on conditional basis subject to the submission of renewal NOC from government for the academic year 2022-23.

8. Continuation of Provisional Affiliation is, therefore, granted to MBA programme with an intake of 120 students (2 batches of 60 students each) at Holy Grace Academy of Management Studies, Kuruvilassery, Mala, Thrissur for the academic year 2022-23 on conditional basis subject to the submission of renewal NOC from government for the academic year 2022-23.

9. Affiliation granted is strictly provisional and only for the academic year 2022-23. The College has to apply for Continuation of Provisional Affiliation to the programme for the ensuing years by remitting the fee fixed by the University along with a copy of the Extension of Approval Order from the apex body concerned.

10. The Selection and admission shall be made only on the basis of the rules and regulations of the University and Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled. Admission to the next academic year shall be made only after obtaining prior permission from the University.

11. The Controller of Examinations shall ensure that examinations are not conducted in the colleges without having valid Affiliation orders.

12. The conduct of University examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

13. The Principal is directed to strictly adhere to the UGC Regulations in engaging faculties in the college and Continuation of Provisional Affiliation for the next academic year will be considered accordingly.

14. In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institutions shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

Important Instructions

- The State Government/ UT/ Directorate of Technical Education/ Directorate of Medical Education shall ensure that 10% of reservation for Economically Weaker Section (EWS) as per the reservation policy for admission, operational from the Academic year 2019-20 is implemented without affecting the reservation percentages of SC/ ST/ OBC(NCL) / General. However, this would not be applicable in the case of Minority Institutions referred to the Clause (1) of Article 30 of Constitution of India. Such Institution shall be permitted to increase in annual permitted strength over a maximum period of two years.
- 2. The Institution offering courses earlier in the Regular Shift, First Shift, Second Shift/Part Time are now amalgamated as total intake and shall have to fulfil all facilities such as Infrastructure, Faculty and other requirements as per the norms specified in the Approval Process Handbook 2023-24 for the Total Approved Intake. Further, the Institutions Deemed to be Universities/ Institutions having Accreditation/ Autonomy status shall have to maintain the Faculty: Student ratio as specified in the Approval Process Handbook.
- Strict compliance of Anti-Ragging Regulation, Establishment of Committee for SC/ ST, Establishment of Internal Committee (IC), Establishment of Online Grievance Redressal Mechanism, Barrier Free Built Environment for disabled and elderly persons, Fire and Safety Certificate should be maintained as per the provisions made in Approval Process Handbook and AICTE Regulation notified from time to time.
- 4. In case of any differences in content in this Computer generated Extension of Approval Letter, the content/information as approved by the Executive Council / General Council as available on the record of AICTE shall be final and binding.
- 5. As per the AICTE Notification dated 29.01.2014 and amended thereto, it shall be mandatory for each Technical Education Institution, University Department and Institution Deemed to be University imparting Technical Education to get accreditation (NBA) for at least 60% of the eligible courses in the next ONE (1) Years' time, otherwise EoA for the subsequent Academic Year (A.Y. 2024-25) shall not be issued by the Council.
- Deemed to be University: Institutions Deemed to be Universities (Running Technical Education Programmes), it is mandatory to have AICTE approval from the Academic Year 2018-19 in compliance of the Hon'ble Supreme Court Order dated 03-11-2017 passed in CA No.17869- 17870 /2017.
