CHAPTER 1 GENERAL INFORMATION

CHAPTER 2

HOSTEL POLICY

All hostellers are required to adhere to the rules and regulations of the hostel. Any breach of rule will invite disciplinary actions against the hosteller. Hostellers can meet the Visitors (Parents / Local Guardian) during the visiting hours with the prior permission of the Warden. Visitors to the hostel inmates will be required to enter their names and address and the name of the student whom they want to see etc. in the register. Check in and Checkout should be properly entered in the register with the Warden.

- Hostellers have to seek the written permission of the Warden & fill the leave form duly signed for going to their homes or to their local guardians in case of emergency or need.
- If any hosteller is found missing from the hostel without permission from the Warden, he/she will be dealt with disciplinary action.
- While visiting the dining hall and the common rooms, all hostellers should be in proper attire.
- Use of narcotics, consumption of alcoholic beverages, smoking, betting, playing of cards and gambling are strictly prohibited.
- Firearms, knives or such other weapons are strictly prohibited in the hostel premises.
- Ragging in any form is strictly prohibited. It constitutes an act of gross indiscipline and
 any person found involved in such an activity will be subjected to appropriate action
 from heavy fine to rustication/expulsion from the college.
- Hostellers are expected to behave with due regards for the comforts and convenience of other colleagues.
- Bursting of crackers, howling, screaming etc. are strictly prohibited.
- It shall be ensured by all hostellers that they do not get involved in fighting among themselves, peer or with juniors. In case such incidents are brought to the management, appropriate disciplinary action will be taken against such students.
- No hosteller should get involved in any argument/heated exchanges with the security and supporting staff. In case of any complaint against them, they should register the same in the register kept with Warden, giving their full details and identity.



- Use of audio equipment/music systems in hostels is acceptable only if it is not objectionable to other residents.
- Any hostel room may be inspected by the authorities at any time.
 No private party shall be organized by any Hosteller in the hostel.
- The Management reserves its right to cancel admission of undeserving hostellers without giving any reason.
- The Management reserves its right to increase the hostel fee. if necessary.
- Meals are prepared as per the menu decided by the Management. No change will be permitted unless decided by the authorities.
- Every case of illness and accident must be reported to the Warden immediately.
- Hostellers suffering from any contagious diseases will not be allowed to stay in the hostel.
- Hostellers shall ensure that lights / fans are switched off when not in use.
- Furniture is not to be removed from one room to another.
- Hosteller will be responsible for the items given to him/her in the room.
- Hostellers should not keep any costly items, jewellery etc. in their rooms. Management will not be responsible for loss of any such items.
- All waste materials should be properly disposed in the bin bag provided. It is the responsibility of the room inmates to keep the bathrooms clean and tidy.
- Inmates are expected to maintain discipline in the hostel and not to cause inconvenience to other fellow inmates.
- Students should utilize the study hour (8.30 P.M to 10.30 P.M On working days, 9.30 P.M to 10.30 P.M non working days) productively for studying in their room and maintain complete silence and discipline during study hour and 'silence hour' (10.30 P.M to 6.30 A.M).
- Students should not carry any unwanted or unauthorized materials in the room.
- Students are completely responsible for their personal belongings and costly things like mobile, laptop and other gadgets.
- Students have to submit Leave forms to the Warden whenever he leaves the hostel, except when going to the college.
- . Food should not be taken to the rooms. On special cases of sickness, prior permission shall be requested from Warden.
- Wearing ID cards while entering/leaving hostel premise IS compulsory.



- Cooking inside the hostel is strictly prohibited. Items like electric cooker, coffee maker, induction stove, bread toaster etc are not allowed inside the hostel premises.
- Students should stay only in the room which is allotted to him / her and should not interchange / shift the rooms without the permission of the warden.
- Students should not spoil the wall, furniture's, door, window or any property of the residence.
- Hostel authorities are responsible for room allotment and their decision is final and binding.
- Hostel timings are to be strictly followed by the inmates.
- The mess timing will be as follows: Breakfast 7.30 to 8.20 am, Lunch 12.30 to 1.30 pm, Dinner 7.30 to 8.30 pm.
- Relaxation in the hostel and the mess timings are not entertained under any circumstances.
- The Gents are expected to be inside the hostel by 9.00 pm on weekdays and at 9.30 pm on Saturday and Sunday. The students are expected to give their roll call before 9.30 pm on week days and before 10.00 pm on weekends.
- The Ladies are expected to be inside the hostel by 7.00 pm on all days. The students are expected to give their roll call before 9.30 pm on all days.
- Students who have obtained roll call extension are expected to give their roll call once they return back to the hostel
- Hostel inmates are expected to obtain prior permission from the hostel authorities by submitting a "sign out" form before they can leave the hostel. The students can register for absence in the biometric systems available in the hostel premises before they leave.
- The students can leave the hostel premises early in the morning hours by 5.30 am with the prior permission of the hostel authorities.
- The students should not screen pirated / unauthorized / unlicensed movies in their computers and common room. Any violation will be dealt severely. Punishment for the same will be decided by the authorities.
- Roll call extension will be given for individuals, members of clubs and festivals till
 11.00 pm.
- Students going out of the campus for any reason must make an entry in the IN / OUT register.



- Students are not allowed to play in the rooms/corridors, except the board games like chess, carom etc.
- Students are not allowed to celebrate any parties (like birthday) inside the hostel.
- Students are not allowed to use the hostel terrace.
- Every student should be responsible to keep his belongings (wallet, laptop, phone etc.) safe. Rooms must be locked while leaving.
- Students should not entertain any unauthorized guest to enter the hostel.
- The quantity of food will be unlimited except in the case of special items.
- Students can entertain their guests. They can entertain their parents as guests in their respective messes on prior intimation and on production of guest tokens.
- The hostel fee and mess fee, prevailing during the academic year should be paid within
 5 working days after reopening of the institution in every semester.
- If a student is taking leave for 15 days or more with prior permission, only the mess fee for that leave period will be refunded.
